The HESI Genetic Toxicology Technical Committee recently held a successful workshop on "Genetic Toxicology at the Crossroads: From Qualitative Hazard Evaluation to Quantitative Risk Assessment" in Lancaster, United Kingdom, on 10–11 July 2014. The workshop brought together 75 experts in the fields of genetic and general toxicology, risk assessment, and computational biology representing industry, academia, and government to address and make recommendations on a path forward on this paradigm-shifting topic. The workshop presentations and conclusions will also be published together in a special issue of *Mutagenesis* in the future.
